A Group is classified as a party of 6 guests or more.

A group reservation remains as 'provisional' until a non-refundable deposit amounting to 12% of the total booking value has been received by Euro Hostels Ltd. Once this deposit has been received the group reservation becomes guaranteed and subject to our Group Terms and Conditions. Euro Hostels Ltd reserves the right to cancel any booking with a provisional status once reasonable efforts have been made to contact you. At this time you will be asked to sign and return a Group Contract.

Once the deposit is received a Confirmation clearly stating the deposit paid will be forwarded to you and will also act as your receipt. A pro forma invoice for the balance of the payment will also be forwarded to you at the time of the deposit payment. The remaining 88% of the total fee must be received by Euro Hostels Ltd no later than 28 days prior to arrival. Please allow an extra 5 working days prior to the payment due date for a cheque payment or bank transfer to clear. Euro Hostels Ltd accepts no responsibility for chasing payment of the balance.

If the remaining balance is not received 28 days prior to arrival Euro Hostels Ltd will endeavour to contact you. In the event you cannot be contacted then the group reservation will be cancelled and the 12% non-refundable deposit will be retained by Euro Hostels Ltd.

A final rooming list and arrival time should be provided to Euro Hostels Ltd 28 days prior to your arrival. Should the numbers in the group fall below the confirmed number then the cancellation conditions below will apply and the rate quoted may be reviewed at Euro Hostels discretion.

Should you be asked to return a Group Contract, the details on the Group Contract are confirmed and guaranteed by both parties upon signature from the nominated group leader and a representative of Euro Hostels Ltd.

Groups containing children (5 years – 15 years) should be accompanied with the following adult supervision levels. If these levels are not met prior agreement, in writing, with Euro Hostels Ltd must be attained:

Up to 10 children - 2 Adults

Up to 20 children - 3 Adults

Up to 30 children - 5 Adults

Up to 40 children - 6 Adults

Above 40 children - Agree levels direct with hostel management

Groups containing youths (16 and 17 year olds) should be accompanied with the following adult supervision:

Up to 10 youths - 1 Adults

Up to 20 youths - 2 Adults

Up to 30 youths - 3 Adults

Up to 40 youths - 4 Adults

Cancellations

Any cancellation from the group must be notified at least 28 days prior to arrival to receive a full refund less the 12% non-refundable deposit already paid.

Final numbers can be adjusted, up or down, up to 7 days prior to arrival date. Increases are subject to availability and will be charged at the current applicable rate. Should the number in the group or nights of stay drop below the original booking, refunds will be as detailed in the cancellation conditions below. The rate may also be reviewed at Euro Hostels discretion.

If any of your group fail to arrive, without notification, on the arrival date then the bed will automatically be charged as a non-arrival for all nights of the stay and there will be no refunds.

If the group falls below our minimum group level of 6 guests due to cancellations or non-arrival then Euro Hostel Ltd will withdraw any group discounts and then the current advertised rate on Euro Hostels website will be applied to the booking.

In the event you wish to cancel your booking the following conditions apply to the total value of your group reservation:

More than 28 days prior to arrival - Full Refund (excluding deposit)

Within 3-4 weeks - 25% Cancellation charge will apply

Within 2-3 weeks - 50% Cancellation charge will apply

Within 1-2 weeks - 75% Cancellation charge will apply

Within 1 week - 100% Cancellation charge will apply

Check-in/out and In-House Groups

Check-in time is anytime after 3pm on the date of arrival. An early check-in from 11.00am is available at a fixed rate supplement, subject to availability.

Check-out time is anytime before 10.30am on the date of departure. A late check-out up to 2.00pm is available at a fixed rate supplement, subject to availability.

All International guests without a UK address will have to provide photo identification in the form of a passport, driving license or European ID Card. All guests will be required to sign a rooming list on arrival which will state they agree to the Euro Hostel Terms & Conditions of stay as displayed at reception.

All Group Reservations are asked to authorise a security bond on arrival; this amount per person will be charged to a Credit or Debit card on check-in. The amount per person will be stated on your Group Contract. This authorised deposit is fully refundable on check-out should all rooms and property be in an acceptable manner. On arrival any room defects should be reported to the Duty Manager.

Room damage will be charged at the current rate for replacement of property or repair to property, the monies will be taken using the security authorisations agreed on arrival. Any amounts that are over and above the deposit paid will also be deducted from the credit or debit card provided.

During your group's stay the Duty Manager nominated by Euro Hostels Ltd reserves the right to inspect any rooms occupied by your group without notice. Supervision from your group leader will be requested but in the event this is not possible then two representatives from Euro Hostels Ltd will carry out the inspection unsupervised.

Should any guests within a group reservation be found to have non-paying guests in their room, the group leader will be responsible for payment of the extra accommodation requirements, failure to pay for non-registered guests may result in the whole group reservation being terminated without refund.

Should any group members become unruly resulting in complaints from other guests, Euro Hostels Ltd reserve the right to cancel the group reservation which will result in early eviction from the property without any monies refunded.

It is illegal to smoke in any of our buildings and Euro Hostels Ltd operates a zero-tolerance smoking policy. Any member or members of a group reservation found to be smoking within the property will have their ongoing reservation cancelled

and asked to leave with no monies refunded. The Duty Manager also reserves the right to apply charges to the individual or group leader for any additional charges due to smoking within the hostel accommodation. Failure to adhere to these conditions will result in the police being notified and criminal charges being brought against the individual(s) concerned.

Any member(s) of a group reservation found to be in possession of any illegal substances will be reported to the police and a possible conviction may result. Immediate eviction from the hostel and life time ban will also be applied to the guest concerned.
